2. The Institution shall remit the affiliation fee as per the following terms :

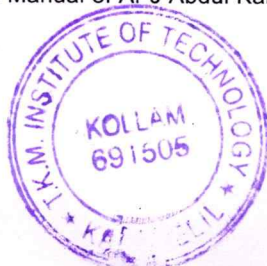

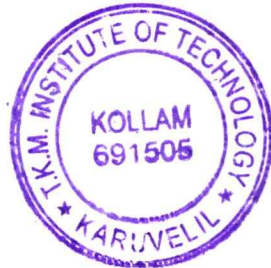
