2. An Expert Team conducted onsite evaluation of the program from 23rd to 25th September, 2022. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The program has been granted accreditation for 3 years. **TKM Institute of Technology, Musaliar Hills, Karuvelil P.O Ezhukone Kollam – 691505 Kerala** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
